LOS CAYOS COMMUNITY DEVELOPMENT DISTRICT PUBLIC HEARING & REGULAR BOARD MEETING APRIL 17, 2024

A. CALL TO ORDER

The April 17, 2024, Regular Board Meeting of the Los Cayos Community Development District (the "District") was called to order at 9:49 a.m. in the offices of Lennar Homes, LLC located at 5505 Waterford District Drive, Miami, Florida 33126.

B. PROOF OF PUBLICATION

Proof of publication was presented which showed that notice of the Regular Board Meeting had been published in *Miami Daily Business Review* on October 6, 2023, as part of the District's Fiscal Year 2023/2024 Meeting Schedule, as legally required.

C. ESTABLISH A QUORUM

Mrs. Perez determined that the presence of the following Board Members constituted a quorum and all was in order to proceed with the meeting: Vice Chairperson Vanessa Perez and Supervisors Marc Szasz and Carmen Orozco.

Also in attendance were District Manager Gloria Perez of Special District Services, Inc., and District Counsel Ginger Wald of Billing Cochran, Lyles, Mauro & Ramsey, P.A.

D. ADDITIONS OR DELETIONS TO AGENDA

There were no additions or deletions to the agenda.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. February 21, 2024, Regular Board Meeting

A **MOTION** was made by Supervisor Orozco, seconded by Supervisor Perez and passed unanimously approving the minutes of the February 21, 2024, Regular Meeting, as presented.

G. OLD BUSINESS

There were no Old Business items to come before the Board.

Mrs. Perez then recessed the Regular Board Meeting and simultaneously called to order the Public Hearing.

H. PUBLIC HEARING

1. Proof of Publication

Proof of publication was presented which showed that notice of the Public Hearing had been published in *Miami Herald* on March 19, 2024, and March 20, 2024, as legally required.

2. Receive Public Comment on the Proposed Rulemaking

Mrs. Perez opened the public comment portion of the Public Hearing. There were no comments made at this time.

3. Consider Resolution No. 2024-03 – Related to DERM Rules

Resolution No. 2024-03 was presented, entitled:

RESOLUTION NO. 2024-03

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE LOS CAYOS COMMUNITY DEVELOPMENT DISTRICT, ADOPTING RULES PERTAINING TO MAINTENANCE AND COMPLIANCE WITH THE DECLARATION OF RESTRICTIVE COVENANT AND ENGINEERING CONTROL MAINTENANCE PLAN RELATING TO PROTECTION OF GROUNDWATER AND CONTAMINATED SOIL ON PROPERTY LOCATED WITHIN THE DISTRICT BOUNDARIES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

RULES FOR COMPLIANCE WITH DECLARATION OF RESTRICTIVE COVENANT AND ENGINEERING CONTROL MAINTENANCE PLAN AS TO USE OF PROPERTY WITHIN THE BOUNDARIES OF THE DISTRICT

(1) General. The Los Cayos Community Development District ("District") joined and consented to a Declaration of Restrictive Covenant ("DRC") recorded on March 28, 2024, at Official Records Book 34156, Page 2261 in the Public Records of Miami-Dade County, Florida ("Covenant"), whereby the District agreed that it was responsible for the obligations described in the Engineering Control Maintenance Plan ("ECMP"), dated December 29, 2023 (attached hereto as **Exhibit 1**), providing for the inspection, maintenance and reporting requirements regarding properties situated within the District boundaries and as described in the DRC. The District will conduct certain routine inspections of property within the District boundaries to ensure compliance with the DRC and ECMP, require notification by the individual property owners of any penetration of the engineering controls on their property and any interaction with groundwater and reporting to the Department of Regulatory and Economic Resources, Division of Environmental Resources Management ("DERM"). Pursuant to the ECMP, the District is responsible for the maintenance of engineering controls, disclosing environmental conditions to prospective contractors, retention of a Florida licensed professional engineer to oversee and document work performed below the engineering controls, and submit Source Removal Reports and Engineering Control Repair reports, as necessary, as described in the DRC and ECMP.

- (2) <u>Inspections</u>. The District shall perform routine inspections under the direct supervision of a professional engineer on a semi-annual basis to determine compliance with the DRC and ECMP. The property owners within the boundaries of the District shall permit the entry of the District personnel to inspect the property owner's unimproved property in accordance of the DRC and ECMP. The property owner shall be notified by the District of the date and general time of the aforementioned inspections.
- (3) <u>Notification</u>. All property owners are required to be in compliance with the DRC. Each property owner shall inform the District, of the following:
 - (a) intention of digging of holes or trenches which disturb or penetrate the engineering controls on the property owner's property; and
 - (b) intention to interact with groundwater on the property owner's property; and
 - (c) proof of permit issued by Miami-Dade County which provides for all requirements of the DRC; and
 - (d) notice of any violations received by Miami-Dade County/DERM regarding or arising out of the requirements of the DRC.
- (4) <u>Compliance</u>. Pursuant to the requirements of the DRC, the CDD requires that individual property owners disclose the environmental conditions and requirements of the DRC and ECMP to prospective contractors, engage a Florida licensed professional engineer to oversee and document work performed on their property, and provide all reports to the District, as required by the ECMP.
- (5) Reporting. It is the responsibility of the District to notify DERM of any violations of the Covenant. If the District is made aware of any violations of the DRC, the District will notify the property owner of said violations and advise the property owner to come into compliance therewith.
- Maintenance. In the event of a failure of the property owner to comply with the requirements of the DRC, the District has the responsibility under the ECMP to repair and restore any damage to the engineering controls on the subject property at the property owner's sole cost and expense. The property owner shall pay all such costs to the District within thirty (30) days of written notice sent by the District to the property owner at the address on file at the County property appraiser for the subject property. If the property owner fails to timely pay all such costs incurred by the District, the District may impose such costs on the property owner as a maintenance special assessment on the subject property.

Ms. Wald provided an overview of the rules pertaining to the maintenance and compliance, as well as the reporting and engineering control maintenance.

A **MOTION** was made by Supervisor Orozco, seconded by Supervisor Perez and passed unanimously adopting Resolution No. 2024-03, as presented.

Mrs. Perez then closed the Public Hearing and reconvened the Regular Board Meeting.

I. NEW BUSINESS

1. Consider Engineering Proposal for DERM Required Environmental Inspection Services

Mrs. Perez advised the Board that Juan Alvarez the District engineer had acquired a proposal from MEC Engineering (MEC) that was circulated via email and provided via handout for the Board's approval consideration.

Mr. Szasz estimated that the services should commence within the next six months.

A **MOTION** was made by Supervisor Orozco, seconded by Supervisor Perez and passed unanimously approving the proposal and engaging MEC Engineering, as per the above proposal, as presented; and further authorizing District Counsel to prepare an agreement.

2. Consider Resolution No. 2024-04 – Adopting a Fiscal Year 2024/2025 Proposed Budget and Setting a Public Hearing Date

Mrs. Perez presented Resolution No. 2024-04, entitled:

RESOLUTION 2024-04

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE LOS CAYOS COMMUNITY DEVELOPMENT DISTRICT APPROVING A PROPOSED BUDGET FOR FISCAL YEAR 2024/2025 AND SETTING A PUBLIC HEARING THEREON PURSUANT TO FLORIDA LAW AND PROVIDING AN EFFECTIVE DATE.

Mrs. Perez noted that she had changed the address on the Resolution to read 5505 Waterford District Drive instead of the previously known address of 5505 Blue Lagoon Drive.

A **MOTION** was made by Supervisor Orozco, seconded by Supervisor Perez adopting Resolution No. 2024-04 and setting the Fiscal Year 2024/2025 Budget and setting the Public Hearing date for <u>Wednesday</u>, <u>June 19th, 2024, at 9:45 a.m.</u> in the offices of Lennar Homes, LLC, 5505 Waterford District Drive, Miami, Florida 33126 and authorizing the publication of the notice, as required by law.

3. Consider Ratification and Approval of Intergovernmental Agreement between the District, the Tax Collector and the Property Appraiser

A **MOTION** was made by Supervisor Orozco, seconded by Supervisor Perez and unanimously passed ratifying and approving the Intergovernmental Agreement between the District, the Tax Collector and the Property Appraiser, as presented.

4. Consider Ratification and Approval of Certain Exempt Information Maintained by the Property Appraiser

A **MOTION** was made by Supervisor Orozco, seconded by Supervisor Perez and unanimously passed ratifying and approving certain exempt information maintained by the Property Appraiser, as presented.

5. Fill Project Update

Mr. Szasz provided an update on the Fill Project, noting that it should be completed by the end of this month, and he anticipates the final billing will be in May for fill from the month of April.

J. ADMINISTRATIVE & OPERATIONAL MATTERS

1. Financial Report

Financials were presented in the meeting materials and were reviewed: Monthly Financial Report-Operating Fund (actual revenues and expenditures with fund balances and availability) and the Budget vs. Actual from October 2023 through March 2024. Available Funds as of March 31, 2024, reflect: \$666,562.39.

A motion for ratification of the financials or any further questions was requested.

A **MOTION** was made by Supervisor Orozco, seconded by Supervisor Perez and passed unanimously ratifying and approving the financials as presented.

K. BOARD MEMBER & STAFF CLOSING COMMENTS

1. Special District Services' Ethics Training Memo

Ms. Wald provided an overview of the presented Memorandum, going over the required ethics training and providing an update on the financial disclosure form.

2. 2023 Form 1 – Statement of Financial Interests

Mrs. Perez reminded the Board that the 2023 Form 1 - Statement of Financial Interests was due July 1, 2024, and indicated that it would only be accepted via electronically beginning this year.

L. ADJOURNMENT

There being no further business to come before the Board, the Regular Board Meeting was adjourned at 9:58 a.m. on a **MOTION** made by Supervisor Perez, seconded by Supervisor Orozco and passed unanimously.

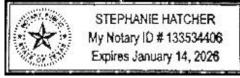
